This letter sets out what EURid has agreed to do in order to demonstrate its commitment to securing and enhancing the stability and interoperability of the Internet's Domain Name System (DNS) for EURid and ICANN's mutual benefit and for the benefit of the local and global Internet community, as it relates to the operation of the eu top-level domain name, .eu in Bulgarian language and Cyrillic script (corresponding A-label: xn--e1a4c, with IANA record at <https://www.iana.org/domains/root/db/xn--e1a4c.html>).

In our role as registry operator for .eu, EURid commits to follow the provisions contained in the 12 October 2014 agreement between ICANN and EURid for the operation of the .eu Registry (the ".eu ccTLD Registry Agreement"). EURid agrees that in the operation of the .eu registry, EURid shall consider the .eu Registry as the "Delegated ccTLD" identified in the .eu ccTLD Registry Agreement and shall conform its operations to the commitments therein. EURid also accepts ICANN's commitment, as it relates to the operation of the .eu registry, to follow the obligations of ICANN as set forth in the .eu ccTLD Registry Agreement.

Further to paragraph 4.5 of the .eu ccTLD Registry Agreement, the level of voluntary financial contribution for the year 2016-2017 as it relates to the .eu Registry shall be no greater than \$500, and EURid shall inform ICANN about the amount of voluntary contribution it intends to provide thereafter on a yearly basis.

EURid looks forward to a long and mutually beneficial relationship with ICANN.
