**ENTRY DENYING PLAINTIFF'S MOTION TO ACCEPT PETITION FILED APRIL 7, 2011**  
**AND**  
**ORDER OF DISMISSAL WITHOUT PREJUDICE**

Plaintiff initiated this action on March 15, 2011 against Defendants Alltel Corporation, Celco dba Verizon Wireless, Verizon Communications Inc., Frontier Communications, Yahoo!, Inc., and Map Communications. Her lawsuit consists of a thirty-five page Complaint and over 2,500 pages of exhibits. She asserts approximately forty claims and seeks damages of ten billion dollars. On March 30, 2011, the Court issued a Notice of Intent to Dismiss this matter without prejudice. The Court indicated that Plaintiff's factual allegations are rambling, disjointed, and sometimes unintelligible and that her Complaint was in violation of Civ. R. 8(A) and Civ. R. 12(B)(6).

Plaintiff has filed a "Motion to Accept Petition," which requests that this action not be dismissed. Upon review, the Court finds that Plaintiff has not cured the deficiencies with her Complaint. Accordingly, her Motion is DENIED, and this action is ORDERED DISMISSED without prejudice. Due to Plaintiff's indigent status, no court costs will be assessed.
