19 I, Heather L. McCloskey, declare:


20 1. I am an attorney at law duly licensed to practice before this Court and

22 UnifiedNames, Inc. Unless otherwise stated, I have personal knowledge of the facts  
23 stated herein and if called as a witness could competently testify thereto.

24 2. I was retained to represent defendants in this case after this Court had  
25 already entered both a temporary restraining order and a preliminary injunction  
26 against defendants, and just prior to May 25, 2007, the hearing at which this Court  
27 entered a permanent injunction against defendants.

28 3. On May 24, 2007, I filed on behalf of defendants a response to the

1 Court's order to show cause regarding the permanent injunction which attached both  
2 the Registrar Accreditation Agreement and the Complaint filed with the American  
3 Arbitration Association pursuant to the arbitration clause in the RAA. At the  
4 hearing on May 25, 2007, the Court noted that it had not had any opportunity to  
5 review the documents submitted by defendants prior to the hearing.
