Dear Ravin Ohri,

Please be advised that as of 5 December 2018, Desi Networks LLC (“Desi Networks”) is in breach of its Registry Agreement with the Internet Corporation for Assigned Names and Numbers (“ICANN”) dated 14 November 2013 (“RA”). This breach results from:

1. Desi Networks’ failure to timely pay past due fees, as required by Article 6 of the RA.

Please refer to the attachment for details regarding this breach.


ICANN requests that Desi Networks cure these breaches by 4 January 2019, 30 days from the date of this letter, by taking the following actions:

1. Provide ICANN with corrective and preventative action(s), including implementation date(s), to ensure that Desi Networks will:
 - a. timely and completely respond to ICANN Contractual Compliance matters; and
 - b. timely make payment of its ICANN fees; and
2. Pay all past and currently due fees.

If Desi Networks fails to timely cure the breaches and provide the information requested by 4 January 2019, ICANN may commence the RA termination process.

Failure to pay fees

Article 6 of the RA requires registry operators to pay Registry-Level Fees on a quarterly basis within 30 calendar days following the date of the invoice provided by ICANN. Desi Networks owes ICANN past due fees, in breach of Article 6 of the RA.
